

Faraday Research – “Free 3-month Subscription Offer 2017” Terms and Conditions

To be eligible for this promotion, clients must:

- Have a live account with City Index UK
- Fund their account within 30 days of their account’s opening date

Full terms and conditions:

1. You agree that by participating in the City Index promotion (the **“Promotion”**) that you will be bound by these terms and conditions (the **“Promotion Terms”**) as well as the general terms and conditions (including any supplemental terms) that apply to your Account (as identified above) (**“Our Terms”**). Capitalised terms and expressions used in these Promotion Terms shall have the same meaning as in Our Terms unless specified otherwise in the Promotion.
2. The Promotion is offered by City Index (**“City Index”**; **“we”**, **“our”** or **“us”**), City Index is a trading name of GAIN Capital UK Limited (Head and Registered Office: Park House, 16 Finsbury Circus, London, EC2M 7EB). GAIN Capital UK Ltd is a company registered in England and Wales.
3. Subject to paragraph 12 below, to be eligible to take part in the Promotion you must:
 - a) be over eighteen (18) years of age; and
 - b) have opened an **“Account”** or has an existing Account with us before the end of the Promotion Period.

Anyone who meets all of the criteria above shall be deemed to be a **“Qualifying Applicant”**.

4. For the purpose of these Promotion Terms:

“The Promotion” shall mean receiving free access to the Faraday Research UK Equities or the Faraday Research UK FX Daily service provided by Trade Facts Ltd (which is an affiliate of GAIN Capital UK Ltd) for three months from when you opt-in to receive trading recommendations from Faraday Research (which is a trading name of Trade Facts Ltd). The service is provided by SMS and email. You can decide which service you would prefer and are allowed to swap services during a 3-month trial period by contacting Faraday Research directly.

“Qualifying Criteria” means a Qualifying Applicant has funded the Account (any amount) during the first month (first month meaning 30 days from the date the Account was first opened).

5. The **“Promotion Period”** will run from 1st December 2016 till 31st December 2017 and may be extended or reduced by City Index without further notice.
6. A Qualifying Applicant who has met the Qualifying Criteria will receive communications with instructions on how to opt-in to receive the Promotion. These communications may take a maximum of 30 days from your Account opening date.

7. This Promotion is strictly limited to one (1) Promotion per Qualifying Applicant and it is available to self-directed trading account holders only. Managed accounts and accounts referred by an Introducing Broker are not eligible.

9. The Account must be open and not the subject of any dispute with us or default at the end of each qualifying month.
10. Without prejudice to the generality of these Promotion Terms, we shall have the sole discretion to determine your eligibility under these Promotion Terms, including, without limitation, whether or not you are a Qualifying Applicant or whether or not you have met the Qualifying Criteria. We have the right not to accept a Qualifying Applicant as a Client for any reason or without reason as we shall determine in our sole discretion.
11. Qualifying Applicants should read these Promotion Terms carefully, as well as Our Terms and the risk warnings. Under no circumstances will we be liable for any losses that Qualifying Applicants may incur as a result of trading on their Account(s).
12. Our employees, or other producers or suppliers associated with this Promotion, their advertising, printing and publicity agencies, and their immediate family members (i.e. any person residing in the household of the aforementioned people) will not be eligible to participate in the Promotion.
13. We reserve the right at our sole discretion to disqualify any individual that tampers or attempts to tamper with the entry process, the operation of the Promotion, or breaches the Promotion Terms or Our Terms.
14. We reserve the right to alter, amend or terminate this Promotion, or any aspect of it, at any time and without prior notice. We may make changes to these Promotion Terms and will notify you of these changes by posting the modified terms on our Website www.cityindex.co.uk. We recommend you revisit these Promotion Terms regularly, and by your continued use of our services you accept any such modified terms.
15. Any dispute or situation not covered by these Promotion Terms will be resolved by our management in a manner it deems to be the fairest to all concerned, and that decision shall be final and/or binding on all entrants. No correspondence will be entered into.
16. If these Promotion Terms are translated into a language other than English, then the English version of the Promotion Terms shall prevail where there is an inconsistency.
17. If any term of these Promotion Terms is found to be illegal, invalid or unenforceable under any applicable law, such term shall, insofar as it is severable from the remaining terms, be

deemed omitted from these Promotion Terms and shall in no way affect the legality, validity or enforceability of the remaining term
