

1. You agree that by participating in the S\$150 City Index Accredited Investor Promotion (the “**Promotion**”) you will be bound by these terms and conditions (the “**Promotion Terms**”) as well as the general terms and conditions (including any supplemental terms) that apply to your Account (as identified above) (“**Our Terms**”). Capitalised terms and expressions used in these Promotion Terms shall have the same meaning as in Our Terms unless specified otherwise in the Promotion Terms.

2. The Promotion is offered by City Index (“**City Index**”, “**we**”, “**our**” or “**us**”) in accordance with these Promotion Terms. City Index is a trading name of StoneX Financial Pte. Ltd. (“**SFP**”) for the offering of dealing services in Contracts for Differences (“**CFD**”). SFP is licensed and regulated by the Monetary Authority of Singapore and acts as Principal for all Transactions for Over-the-Counter Derivatives (“**OTC**”) including CFDs. Company. Reg. No.: 201130598R.

3. To be eligible to participate in this Promotion you must:

- a. be over eighteen (18) years of age;
- b. apply for and be approved (by City Index, in its sole discretion) for Accredited Investor status after 10th Sept 2019;
- c. hold an open City Index Singapore account (“**Account**”); and
- d. have opted in to this Promotion via the claim link within the Accredited Status Welcome Email to be sent to you if you are approved for Accredited Investor status.

Any client who satisfies all of the criteria above shall be deemed a “**Qualifying Applicant**”.

4. Subject to these Promotion Terms, we will credit a bonus of S\$150 (“**Bonus**”) to a Qualifying Applicant’s Account within 7 days of that Qualifying Applicant validly claiming this Promotion in the manner outlined in paragraph 3 above. The Bonus can be used for trading (as margin for existing positions or to open new positions) or withdrawn.

5. Your Account must be open and not the subject of any dispute with us or in default on the date the Bonus becomes payable. Failure to comply with this paragraph 5 shall result in the loss of your entitlement (if any) to the Bonus under the Promotion. The Promotion will run for such time as we may, in our absolute discretion, determine.

6. Under no circumstances will we be liable for any losses that a Qualifying Applicant may incur as a result of trading on their Account(s). This Promotion is not intended to change any client’s risk preferences or investment strategies and we accept no responsibility for the same.

7. Notwithstanding any other provision of these Promotion Terms, we shall have the sole discretion to determine your eligibility under these Promotion Terms, including, without limitation, whether or not you are a Qualifying Applicant or an Accredited Investor. We have the right not to accept a

Qualifying Applicant at all or as an Accredited Investor for any reason or without reason as we shall determine in our sole discretion.

8. Our employees or other producers or suppliers associated with this Promotion, their advertising, printing and publicity agencies, and their immediate family members (i.e. any person residing in the household of the aforementioned people) will not be eligible to participate in the Promotion.

9. In the event that a person takes part in this Promotion who does not meet the qualifying criteria set out in these Promotion Terms, or breaches these Promotion Terms or Our Terms, we reserve the right, without prejudice to any other rights under these Promotion Terms or Our Terms, to immediately remove the Promotion from the applicable Account, including, without limitation, removing any credit applied to the Account. In addition, we reserve the right at our sole discretion to disqualify any individual that tampers with or manipulates (or attempts to tamper with or manipulate) the entry process or the operation of the Promotion, who breaches the Promotion Terms or Our Terms or who engages in any predatory or abusive trading practices.

10. We reserve the right to alter, amend or terminate this Promotion, or any aspect of it, at any time and without prior notice. We may make changes to these Promotion Terms by posting the modified terms on our website. We recommend you revisit these Promotion Terms regularly, and by your continued use of our services you accept any such modified terms. 11. Any dispute or situation not covered by these Promotion Terms will be resolved by our management in a manner it deems to be the fairest to all concerned, and that decision shall be final and binding on all entrants. No correspondence will be entered into.

12. If these Promotion Terms are translated into a language other than English, then the English version of the Promotion Terms shall prevail where there is an inconsistency.

13. A currency conversion (at a rate determined by City Index) will be applied to all accounts not trading in a Singapore Dollar (SGD) base currency.

14. If any term of these Promotion Terms is found to be illegal, invalid or unenforceable under any applicable law, such term shall, insofar as it is severable from the remaining terms, be deemed omitted from these Promotion Terms and shall in no way affect the legality, validity or enforceability of the remaining terms.

15. This Promotion is available to self-directed Qualifying Applicants only. Managed accounts and accounts referred by an Introducing Broker are not eligible to participate in the Promotion.

16. Strictly one Bonus per Qualifying Applicant, including linked accounts, joint accounts or corporate accounts, IP address and/or home address. Clients who have multiple accounts that are upgraded to Accredited Investor status will not receive multiple Bonuses.

17. The Promotion will be governed by the laws of Singapore and the Singapore courts shall have the exclusive jurisdiction over any matter or dispute arising from the Promotion.
