Demonstration account disclaimers, terms and conditions

The following disclaimers, terms and conditions (“the Terms”) apply to your use of the Interactive Markets (hereinafter “We”, “Us, or “Our”) demonstration account platform (“the Demo Account”) and have contractual effect in respect of your use of the Demo Account:

1. The Demo Account is a form of trading simulator. Success or failure in simulated trading bears no relation to probable future results with any live trading that you may choose to engage in, and you should not expect any success with the Demo Account to be replicated in actual live trading.
2. Contracts for Difference (“CFDs”) trading and spread betting is not appropriate for everyone. Please be aware that any application to Us for a live trading account could be declined, and no reference is made by Us to the use of any Demo Account when considering live trading account applications.
3. The pre-set ‘balance’ of £10,000 is a hypothetical amount. You are not trading with real money and for the purposes of this Demo Account cannot make or lose any actual money.
4. If you have a Demo Account containing both CFD and spread bets, the ‘balance’ of £10,000 will be used across both accounts.
5. You warrant that: (a) you use the Demo Account solely in your personal capacity and not on behalf of a company; (b) in the event that you are registered or qualified as a professional securities trader or investment adviser that you use the Demo Account solely in relation to the management of your or your immediate family’s personal funds; (c) you agree not to distribute, re-publish or otherwise provide any data from the Demo Account service to any third party in any manner, and: (d) you repeat the above warranties (as applicable) each time you access the Demo Account.

6. We will retain your acceptance to these Terms in our records.
7. The Demo Account will expire after a period of two weeks.
8. We have no liability to you should the Demo Account platform be inaccessible at any time.
9. We reserve the right to amend these Terms and/or withdraw the Demo Account at any time.

In consideration of Our providing you a Demo Account and/or data, you agree to the acceptance of the above Terms.
